
ABOUT THE FOUNDATION



The Pierce County Dental Foundation is a nonprofit, charitable organization formed in 2003 by members of the Pierce County Dental Society. Since its inception, the Foundation has raised and dispersed funds to numerous nonprofit organizations in Pierce County dedicated to oral health care and education. In addition, a considerable amount of funds raised through the Foundation are utilized by the Pierce County Dentists Care Program to provide care to the area's underserved population.

The Internal Revenue Services recognizes the Pierce County Dental Foundation as a tax-exempt 501(c) 3 charitable organization. Contributions to the Foundation by individuals, corporations or other foundations are fully deductible.

PIERCE COUNTY DENTISTS CARE PROGRAM

The Pierce County Dentists Care Program was established in 2004 by the Pierce County Dental Foundation and the Pierce County Dental Society to meet the oral health needs of underserved children and adults in the community. Candidates for the program are identified and referred through school screenings and by local agencies. Participants are then placed with one of many Pierce County dentists who have volunteered to provide emergency care and services. Monetary donations to the program help offset laboratory and material fees.
