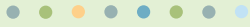

Fourth annual Chip! for Teeth raises \$44,000

The DFO held its fourth annual Chip! for Teeth golf tournament on May 30 at Riverside Golf and Country Club, raising more than \$44,000, a \$6,000 increase from the 2007 event.

“This year’s tournament was a huge success,” said Judy Edgerly, DFO Executive Assistant. “We had 27 teams participating — and thanks to our

DFO Tooth Taxi brings bright smiles to Sweet Home

Following its unveiling at Pioneer Courthouse Square on Aug. 27, the Dental Foundation of Oregon (DFO) Tooth Taxi headed out to Sweet Home, Ore., where it spent the week at Foster Elementary School.

A total of 48 children were screened on Monday and 15 were scheduled for treatment on Tuesday. For about one-third of the children who visited the Tooth Taxi during the week, it was their first visit to the dentist.

“Our expectation was that [in the course of the screenings] we would see kids with the most neglect,” Mike Goger, D.M.D. and Tooth Taxi

volunteer dentist said. “We certainly saw some with advanced, rampant decay to the point where they’re going to have some teeth removed. We saw others with moderate decay that will have some fillings placed. Then there were half a dozen or so who looked spotless and simply received fluoride varnish.”

A BUSY DEBUT

The DFO worked tirelessly with support from OEA Choice Trust and The ODS Companies to make the vision of bringing dental care to children in need throughout the state a reality.

The Tooth Taxi hits the road

“If you build it they will come,” is a line from the movie “Field of Dreams.” That is exactly what is beginning to happen with the Tooth Taxi project.

The Dental Foundation of Oregon’s (DFO) dream of a mobile health clinic began three years ago in response to Oregon’s high rate of dental decay and lack of access to dental care. In Oregon, 22 of the 36 counties have a shortage of dental professionals. Through a partnership with The ODS Companies and the OEA Choice Trust, the Tooth Taxi program was established to address both issues.

The program includes the Tooth Taxi, a mobile health clinic that travels to schools to provide direct dental care and oral health education to thousands of children throughout Oregon. The Tooth Taxi is a state-of-the-art dental clinic — and with the help of OEA Choice Trust, Oregon school doors will open, allowing us to provide dental care on site to those who need it most.

The Tooth Taxi was unveiled on August 27 at Pioneer Courthouse Square, in downtown Portland. Hundreds of people passed through the van to see the most modern dental equipment and view the kid-friendly graphic exterior. Members of the press and media were also present for the inaugural ceremonies. The van was built by American Dental International and the exterior graphics were designed by SPUNK Design Machine of Minneapolis.

Mary A. Daly, program manager, Dr. Weston W. Heringer,

Jr., pediatric dentist for the clinic and Peggy Wallis, dental assistant, put the Tooth Taxi into action in early September at two Head Start programs. The first took place in Independence and the second in Milwaukie, Ore. During the two visits, 39 children were screened; received oral health education and 18 received dental services. In all, more than \$10,000 in dental treatment was provided.

In late September, the Tooth Taxi officially began in Sweet Home, Ore. for its first full week. We are pleased and honored that Dr. Mike Goger, dentist and DFO board member, and Amy Berg, dental assistant, were able to volunteer on the Tooth Taxi for the entire week to help provide care. Melissa Cheek, dental hygienist, provided oral health education in the classrooms.

We know that it takes a whole community to help provide the best dental care to our children. The Tooth Taxi program needs volunteers. We not only need dental volunteers on board the taxi but donations to keep the van rolling down the highways and into the schools. Please help if you can. DFO distributes more than \$76,000 in 2008 grants

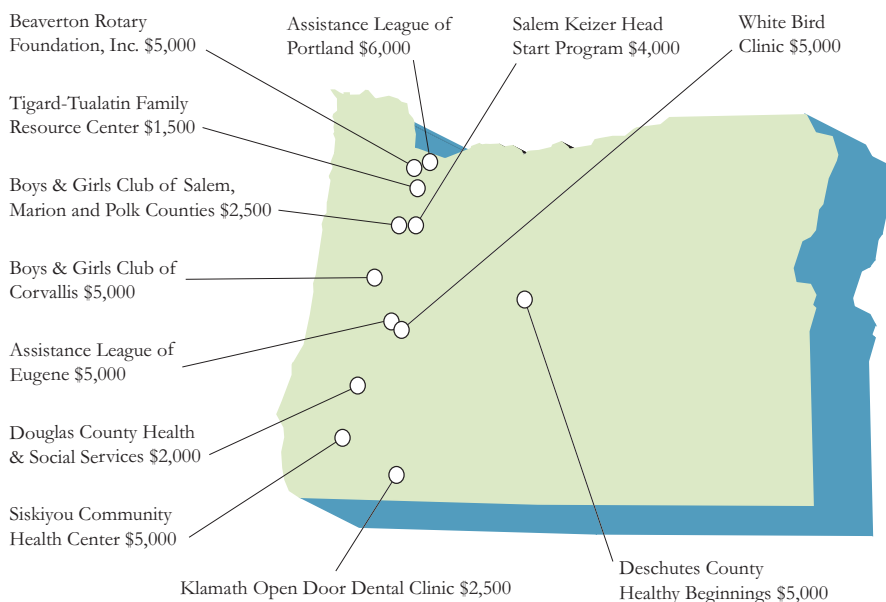
The Dental Foundation of Oregon (DFO) awarded \$76,312 in grants to various programs throughout the state during 2008.

The grant committee strictly evaluated applications against the foundation's newly adopted mission of improving oral health for Oregon's children. Specifically, grant applicants are judged using the following criteria:

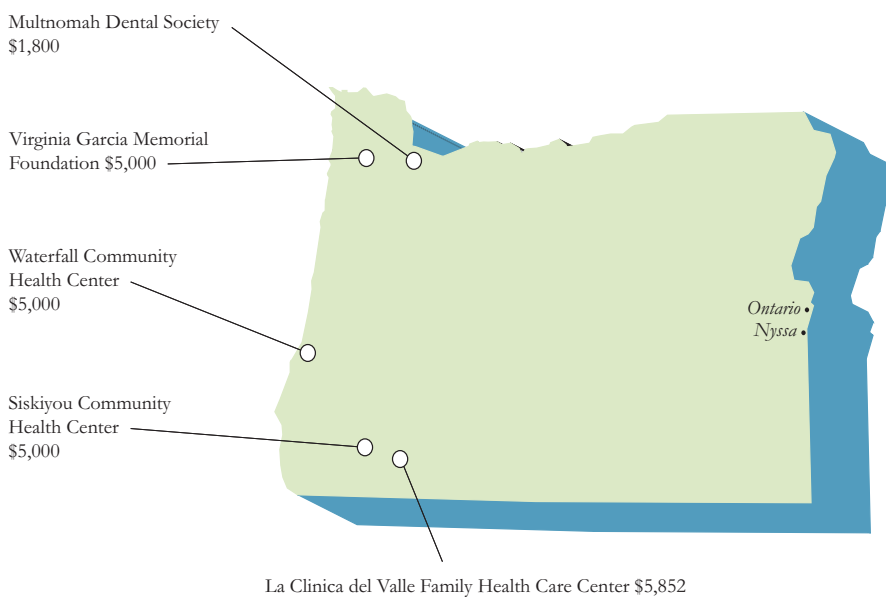
- They provide emergency dental care for children who are disadvantaged and do not have access to care.
- They prevent dental disease through support of programs that provide dental health education to the community and to assist children and low-income families to access dental healthcare.

Note: the grant awarded in Idaho this fall to Valley Family Health Care will be used in two of the organizations' Oregon clinics, which are located in Nyssa and Ontario.

Thanks to the months of work and planning, the Tooth Taxi's first day of treatment was brisk. The staff juggled treating children and greeting numerous visitors, often stopping to explain procedures and field questions from the media.

School nurse Joan Pappin, R.N., coordinated the logistics of the Tooth Taxi's visit and escorted students between the classroom and the van. Pappin said she was pleased with the way the prescreening process worked.

"I think everything worked as I thought it would," Pappin said. "The category fours rose to the top right away and we were able to get them seen immediately."

A SUCCESSFUL FIRST DAY

At the end of the day, the Tooth Taxi personnel felt very good about what had been accomplished.

"Things went great," Goger said. "From a clinical standpoint, I didn't see any chronic infection today, which is good. I think what amazed me is that, for the amount of decay that's present in these kids' teeth, I didn't see a single child who complained of a toothache — and some of the decay I saw has been going on for quite awhile."

Dr. Weston W. Heringer, Jr., D.M.D. and pediatric dentist for the clinic, agreed. "We had a great day," he said. "Part of what appeals to me about this job is that every day is going to be a new adventure."

Peggy Wallis, extended function dental assistant, said she enjoys the adventure and excitement that comes from dealing with the unexpected.

"We're going to be doing something different, going

different places and seeing different people," she said. "It's not like being in an office where it's easy to get into the same old routine day after day. Out here, you have to be flexible and just sort of go with the flow. I enjoy that, and I would encourage any dental assistant who is feeling a little burned out in their job to volunteer with us."

MOVING FORWARD FOR MORE SMILES

Program Manager Mary A. Daly also sees immense potential in the future of the Tooth Taxi.

"I think it's going to help us make a real difference," she said. "The Tooth Taxi is a 38-foot roving billboard for oral health. In addition to helping underserved children, it can provide so many positive messages about the importance of good dental care. With the support of dental professionals, I know we can change the results of the next Smile Survey. We can provide education to kids about oral hygiene. We can plant the seed about the importance of a healthy mouth and a positive experience at the dental office. It's something we can all get excited about."

Heringer summed it up well. "Life should be an adventure," he said. "The Tooth Taxi is going to be an adventure for our sponsors, our patients and for everyone who volunteers aboard this van. I've been a dentist for 28 years, but I've never been more excited to be practicing dentistry than I am right now."

Frequently asked questions about the Tooth Tax

What is the Tooth Tax?

The Tooth Tax is the project of the Dental Foundation of Oregon (DFO), in partnership with the OEA Choice Trust and The ODS Companies.

What are requirements for treatment?

An up-to-date medical history signed by a parent or legal guardian and a signed permission slip from a parent or legal guardian.

Which students can receive this treatment?

Students who are enrolled in the free or reduced lunch program, students without dental insurance, and those with acute need are eligible to receive care on the Tooth Tax.

What are the age limits?

We will treat students in kindergarten through 12th grade who meet the other requirements, regardless of age.

What type of treatment will you provide?

The Tooth Tax will provide basic dental care, including exams, cleanings, sealants, restorations and extractions.

Are you equipped to handle acute dental needs?

Yes.

What are the qualifications of the professionals on the van?

The van is overseen by a dentist licensed in the state of Oregon.

What if the student needs follow-up care?

We will provide a phone number to call for a referral.

What if the student needs an antibiotic or fluoride?

The need will be determined by the treating dentist. Antibiotics and fluoride will be handed out on a limited basis. No narcotics or pain medication will be available or will be prescribed from the van.

What if the student has dental insurance?

Preference will be given to the uninsured, those on the free and reduced lunch program and those with acute pain.

Where will the patient files be kept?

All files will be electronic records.

Will there be an educational/prevention component program with the van?

Yes, we will work closely with you to develop a program that fits your school's needs. This may include communication via assembly or in-class activities.
