

## NorthView Family Dental \$20K Smile Giveaway

### OFFICIAL RULES OF ENTRY ELIGIBILITY

All eligibility requirements associated with the Official Rules of the NorthView Family Dental \$10K Smile Giveaway apply. All Entrants must be (18) years or older and legal residents of United States.

Employees of NorthView Family Dental and their immediate family members and household members are not eligible to win. "Immediate family members" are parents, stepparents, stepchildren, children, siblings, step-siblings, spouses and in-laws. "Household members" are people who share the same residence for at least three months in one calendar year.

### OVERVIEW

Patients will have the opportunity to submit a video entry anytime between November 6, 2017 and December 31, 2017. The winners selection will be as follows:

NorthView Family Dental's \$20K Smile Giveaway contestants will be selected from eligible and approved entries (see Entry Requirements) by an independent panel of judges. These entries will be collected until January 2, 2018.

The NorthView Family Dental staff will narrow the submissions down to (5) finalists. The 5 finalists will be posted on a voting gallery on Facebook from January 8 through February 2, 2018 and the public will vote for (3) finalists via our Facebook page. The (3) finalists *with the top number of "likes" on their post on our **FB page*** as of February 2, 2018 12:00AM will be our 3 final contestants.

Each of the (3) finalists will receive a free exam from NorthView Family Dental. After all 3 have been examined, Dr. Leale and Dr. Startin will pick the winner, who will receive up to \$20,000 worth of dental work from NorthView Family Dental.

The winner will be announced on February 16, 2018.

#### ENTRY REQUIREMENTS

- Name & name of the person you're entering (if not you)
- Phone number
- City & State
- Email address
- Age
- Names of any additional people that appear in your video/photos
- A title for your Entry

AND

- A video submission - no more than 3 minutes long - explaining why you are a good candidate for the giveaway and why you deserve the \$20K Smile
- A small 2-3 sentence introduction for your video submission
- Include a link to your youtube submission, which needs to be titled, "NorthView Family Dental \$20K Smile Giveaway 2018"

OR

- Photo(s) of your smile
- A short story (300 words or less) explaining why you are a good candidate for the giveaway and why you deserve the \$20K Smile

Feel free to get creative. Pull heartstrings, make us laugh, tell us a story or have someone tell it for you. Then simply upload the video from your cell phone!

## **Ideas For your Story:**

Tell a personal story of your current smile, what you don't like about it, how your current smile has affected you. Explain how a new smile would change your life.

Show your current smile on the video (or photograph). Explain your situation and why you haven't been able to fix your smile in the past.

If you are nominating someone else in your video, show a picture that demonstrates their smile in your video.

\*Videos/photos must not infringe on any 3rd party rights. Any people other than yourself must be identified by name and age.

Once the video has been uploaded and the entry email has been received, the entry is final and cannot be modified, supplemented or edited. Entries that fail to adhere to any of the requirements set forth in these Official Terms and Conditions, including the requirements set forth in this section, as well as the requirements set forth in the official terms and conditions as determined by Sponsors, and/or the Contest Administrator, in their sole discretion, will be Disqualified.

Sponsors are not responsible for the late or incomplete entries. If a problem occurs during the online submission process or in uploading a video, Entrant should receive an "error" Message. However, the responsibility to electronically complete the Entry process and upload a video is the Entrants and neither Sponsor or Contest Administrator shall be responsible for any video not actually received due to incomplete or improper submission. Similarly, neither sponsor nor Contest Administrator has any obligation to advise Entrant of an incomplete entry or video submission.

## **CONTENT REQUIREMENTS**

If the video was taken professionally, the Entrant must have permission from the person/business that required said video. Before submitting the video an Entrant must be able to obtain a signed release from the videographer upon the request of Sponsor. If the video includes a person other than the Entrant, the Entrant must have permission from that person to submit the video. Entrant must be able to obtain a signed release from the owner upon request of the Sponsor.

Only mentions/images of NorthView Family Dental and its staff members are allowed in the video. Any entry that includes a video that contains any other mentions images of any other dental practices mentions/images may be ineligible. Judging of the Contest Entries will not be influenced by the inclusion or exclusion of the NorthView Family Dental logo, name or staff members in the video.

Conditions of entry: Entrant warrants and represents that the video:

- a. is original and has been legally created;
- b. does not infringe on the intellectual property, privacy, publicity rights, ownership or any other legal or moral rights of any third-party;
- c. has not been entered in previous contest or won previous awards
- d. is suitable for public viewing

By submitting an entry, Entrant represents that he/she owns all rights to each element of his her Entry, including, without limitation, the copyrights in the video, and any other music or media and therein. Sponsors determination as to whether the video violates the rights of any third-party is final.

Each Entrant irrevocably grants Sponsor and its affiliates, legal representatives, assigns, agents, and licenses, the unconditional and perpetual right and permission to reproduce, encode, store, copy, transmit, publish, post, broadcast, display, publicly perform, adapt, exhibit and or otherwise use or reuse without limitation as to when or to the number of times used, on an exclusive basis within the dental industry, each element of the Entrants entry, and use of the Entrant's name, likeness, photograph, (collectively "likeness") and or statements regarding his/her participation in this contest (with or without using the Entrant's name) in any and all media without limitation as to time or territory and without additional compensation or approval from the Entrant or any other party. Entrant waves intellectual property rights, privacy, publicity rights, or other legal or moral rights that might preclude the sponsor's use of any element of the entry, and agrees not to sue or assert any claim against the Sponsor for the use of any element on the entry or Entrant's likeness or statements. ## SELECTION OF CONTESTANTS AND FINALISTS

1) Entries will be screened by a qualified panel of experts who will evaluate each entry based on the following criteria:

- Relevance to contest description
- Sense that there is a story being told
- Accuracy of information presented
- Inclusion of a three minute or less video link to YouTube video
- Video is titled NorthView Family Dental \$20K Smile Giveaway 2018
- Appropriateness of information presented for publicly display

Entries that meet the above requirements will be considered a \$20,000 Smile Giveaway Contestant and will be subject to verification.

2) The verified Contestant's entries will be posted on the Sponsor's website at NorthViewFamilyDental.com (the Website.) Entries will be posted for the public to vote on NorthView Family Dental public Facebook page for their favorite entry at the Facebook page.

Entries may also be posted for public viewing on other social media pages operated by Sponsor during the same period, at Sponsor's sole discretion. Limit one vote per entry per day.

The Contestant with the most votes will be declared a "Finalist" and will be named one of the 5 finalists in the \$20,000 Smile Giveaway. In the unlikely event of a tie those entries involved in the tie may be reposted or voted on by an independent panel of judges.

A contestant may encourage family and friends to vote for his or her Entry, but a contestant may not attempt to induce others to vote for his or her entry through the use of any incentive, sweepstakes, or other promotion. Any use of automatic voting methods by any party will void all such votes and will result in the contestant's entry and question being declared ineligible and disqualified from the contest. Any attempt by a contestant and/or his/her family, friends or community to vote more than one vote per day using "boost" technology and/or any other fraudulent mechanism as determined by sponsor at its sole discretion, shall give sponsor the right to disqualify the Contestant in Sponsor's reasonable discretion.

All completed documents must be returned to sponsor within 7 days of the date notice was sent or Contestant

status will be forfeited. Notification of Contest Winner status must be kept confidential until the Contestants or Winner is announced by Sponsor. Failure to comply with this rule may result in disqualification. No substitute of prize will be offered, except at the sole discretion of the sponsor. Prizes are nontransferable. If for any reason the contestant is not capable of running as planned including without limitation, infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes which may corrupt or affect the administration, security, fairness integrity or proper conduct of the Contest, Sponsor reserves the right at its sole discretion to cancel, modify or terminate the Contest.
