Dear Dental Society Members,

Welcome to the November Meeting of the Clark County Dental Society! We have a guest speaker from NORDIC, Melissa Sanchez. She is presenting information on cyber breaches, what constitutes a breach, federal and state laws, and how to be HIPPA compliant.

Cybersecurity vulnerabilities and intrusions pose risks for every dental office using computer technology. Not only is there economic risk, our reputations are at risk. There are significant benefits for care delivery and organizational efficiency from the expanded use of networked technology, internet-enabled medical devices, electronic databases, and other networked technology. These benefits also increase exposure to possible cybersecurity threats that require dentists to evaluate and manage new risks. We can prepare and manage such risks by viewing cybersecurity not as a novel issue but rather by making it part of our existing governance, risk management, and business framework. We will want to ensure that any approach that is adopted remains flexible and resilient to address threats that are likely to be constantly evolving. Ms. Sanchez will be sharing important information to address these issues.

Clark College Dental Hygiene students will be seeing patients for restorative services from January through June 2017. There is a big need for a greater pool of dentists to come and help the students on Fridays from 1-3 pm with an occasional Wednesday evening from 6-9 pm.
