



## BENEFITS TO YOU


In addition to knowing that generations of Oregon children will benefit from better oral health as a result of your gift, there may be many other benefits to giving:

### IMPROVING ORAL HEALTH FOR OREGON'S CHILDREN

Dental professionals know oral disease is a serious problem for many children. That's why the Oregon Dental Association founded the Dental Foundation of Oregon (DFO) in 1982. DFO works to improve oral health by supporting non-profit dental programs with community grants, by educating the public about the importance of good oral health, and by delivering direct dental care and education on our mobile dental van, the Tooth Taxi.

There will always be a need to take care of those less fortunate, and though our challenges may shift and our programs evolve, we have established the Cornerstone Society to ensure that DFO is here to represent dentistry and serve Oregon children for many years to come.

Join the Cornerstone Society today by naming DFO in your will or estate plans. It is surprisingly easy to do, and it's a great way to leave a legacy that will help those less fortunate and honor your profession.

### LEAVING A LEGACY IS EASY

The Cornerstone Society honors donors who have named the DFO in their estate plans. Become a member of the Cornerstone Society simply by letting us know that you have made a testamentary provision. You do not need to disclose the size of your gift, but you may wish to share a copy of the section of your will or trust that references the DFO. If you prefer, you may join the Cornerstone Society anonymously.

### PLAN YOUR GIFT, YOUR WAY

There are many ways to plan a gift to DFO. Consult your legal or financial advisor to determine which method is right for you.

### BEQUESTS

Allocate all or part of your estate to the DFO with a provision in your will or estate plan. This simple form of planned giving may also offer tax advantages and allow you to make a larger gift than otherwise possible. It can be as simple as inserting a few sentences into a new will, or adding a simple amendment to an existing will. Bequests can be a set amount, a percentage, a specific asset, a residual amount or a contingent bequest.

### BENEFICIARY

Name DFO as a beneficiary of your IRA, 401(k) or other retirement plan. These investment vehicles can be taxed twice at death – once to the estate and again to the heirs. You may gain significant tax advantages by naming DFO as a beneficiary for some or all of an account. Naming DFO as a full or contingent beneficiary of your life insurance policy is also a great way to make a substantial gift to DFO after you are gone.



### GIFT OF APPRECIATED PROPERTY OR ASSETS

You can donate securities or real estate that has appreciated in value and may avoid the high capital gains taxes by gifting some or all of it to DFO.

### CHARITABLE TRUSTS

A Charitable Remainder Trust provides a set income for you or your named beneficiary and an immediate income tax deduction. After the trust ends, the DFO receives the remainder. A Charitable Lead Trust pays an income to the DFO for a period of years then you or your heirs receive the remainder. It allows you to pass assets to heirs intact at a reduced cost.

### CHARITABLE GIFT ANNUITY

Make an irrevocable transfer of property (cash or marketable securities) in exchange for a contract that pays you an annuity for life. Because the value of the property/security exceeds the value of the annuity, it is partially a gift to DFO.
